1. Introduction	1.1	Bidders shall adhere to all the requirements of this RFP, including any amendments in Writing by ISA.
	1.2	Any Proposal submitted will be regarded as an offer by the Bidder and does not constitute or imply the acceptance of the Proposal by ISA. ISA is under no obligation to award a contract to any Bidder as a result of this RFP.
2. Fraud & Corruption, Gifts and Hospitality	2.1	ISA strictly enforces a policy of zero tolerance on proscribed practices, including fraud, corruption, collusion, unethical or unprofessional practices, and obstruction of ISA vendors and requires all bidders/vendors observe the highest standard of ethics during the procurement process and contract implementation.
	2.2	Bidders/vendors shall not offer gifts or hospitality of any kind to ISA staff members including recreational trips to sporting or cultural events, theme parks or offers of holidays, transportation, or invitations to extravagant lunches or dinners.

	26.2 Any effort by a Bidder or anyone on behalf of the Bidder to influence ISA in the examination, evaluation and comparison of the Proposals or contract award decisions may, at ISA's decision, result in the rejection of its Proposal and may be subject to the application of prevailing ISA vendor sanctions procedures.
27.Evaluation of Proposals	27.1 The Bidder is not permitted to alter or modify its Proposal in any way after the proposal submission deadline except as permitted under Clause 24 of this RFP. ISA will conduct the evaluation solely on the basis of the submitted Technical and Financial Proposals.

28.Preliminary Examination	28.1 ISA shall examine the Proposals to determine whether they are complete with respect to minimum documentary requirements, whether the documents have been properly signed, and whether the Proposals are generally in order, among other indicators that may be used at this stage. ISA reserves the right to reject any Proposal at this stage.
29.Evaluation of Eligibility and Qualification	B. Eligibility and Qualification of the Bidder will be evaluated against the Minimum Eligibility/Qualification requirements specified in the Section 4 (Evaluation Criteria).
	 C. In general terms, vendors that meet the following criteria may be considered qualified: i. They are not included in the UN Security Council 1267/1989 Committee's list of terrorists and terrorist financiers. ii. They have a good financial standing and have access to adequate financial resources to perform the contract and all existing commercial commitments, iii. They have the necessary similar experience, technical expertise, production capacity where applicable, quality certifications, quality assurance procedures and other resources applicable to the provision of the services required; iv. They are able to comply fully with ISA General Terms and Conditions of Contract; v. They do not have a consistent history of court/arbitral award decisions against the Bidder; and vi. They have a record of timely and satisfactory performance with their clients. vii. The consulting firm should provide credentials, through adequate references or documentation, their current local presence in the ISA focus regions. Past experience of working with ISA and/or with multilateral/international organizations will be an added advantage.
30.Evaluation of Technical and Financial Proposals	 30.1 The evaluation team shall review and evaluate the Technical Proposals on the basis of their responsiveness to the Terms of Reference and other RFP documents, applying the evaluation criteria, sub-criteria, and point system specified in the Section 4 (Evaluation Criteria). A Proposal shall be rendered non-responsive at the technical evaluation stage if it fails to achieve the minimum technical score indicated in the BDS. When necessary and if stated in the BDS, ISA may invite technically responsive bidders for a presentation related to their technical proposals. The conditions for the presentation shall be provided in the bid document where required. 30.2 In the second stage, only the Financial Proposals of those Bidders who achieve the minimum technical score will be opened for evaluation. The Financial Proposals corresponding to Technical Proposals that were rendered non-responsive shall remain unopened, and, in the case of manual submission, be returned to the Bidder unopened. 	Proposals submissions, ISA will not request for the password of the Financial Proposals of bidders whose Technical Proposal were found not responsive.
	30.3 The evaluation method that applies for this RFP shall be as indicated in the BDS, which may be either of two (2) possible methods, as follows: (a) the lowest priced method which selects the lowest evaluated financial proposal of the technically responsive Bidders; or (b) the combined scoring method which will be based on a combination of the technical and financial score.
	30.4 When the BDS specifies a combined scoring method, the formula for the rating of the Proposals will be as follows:

Section 5. Terms of Reference

1. BACKGROUND

Global attainment of the SDG goal of affordable and universal clean energy access remains a key priority for the International Solar Alliance (ISA). The ISA is committed to facilitating solar energy deployment to remote and inaccessible communities in Pacific Island States as a key driver of inclusive growth and gateway to abating climate change.

The ISA, in keeping with its 5-year strategic plan to deliver relevant programmatic support to member countries to accelerate the adoption of solar energy, therefore aims to provide technical assistance and regulatory support to its member states in establishing sustainable and viable solar-receptive regulatory frameworks.

2. Project Title

Developing appropriate regulatory frameworks for sustainable and scalable solar energy systems in Pacific Island States.

3. Project Description

The project will be a broad-based flexible engagement designed in line with each country's assessed and requested needs in close cooperation with the relevant government agencies and/or Ministry (s). The project will focus on key policy and regulatory actions to expand solar energy development in the short and medium term using least-cost strategies to ensure energy security and combat climate action in the focus countries.

The project's focus will be two-fold – recommending business models with least-cost strategies for accelerating the development of requisite policy, and developing requisite regulatory frameworks for scalable and sustainable solar-energy deployment in each country.

This support will be a high-level policy and regulatory support targeted to suit each country's regulatory, financial, and socio-political needs.

5. Scope of Work

ISA has identified certain countries- Tuvalu, Solomon Island, PNG, Kiribati & Marshall Island² (**Potential Countries**) to serve as focus countries for the regulatory support at this time.

Based on the response and interest of countries, additional countries may be included in the assignment, to a maximum of ten (10) countries.

In addition to the phases detailed under Paragraph C above, the successful contractor would:

- a) Conduct comprehensive and qualitative research and analysis of existing and emerging policy/regulatory frameworks relating to solar energy in the aforementioned countries (and additional countries where included) and prepare a report on the gap analysis for existing, potential, and/or policy/regulatory constraints to sustainable mini-grids and other applicable solar systems like solar pumps, solar rooftops, etc. in the focus countries.
- b) Support and participate in ISA events and programs to engage with other stakeholders in ISA member countries on discourse or modalities for regulatory support. This support may include drafting position papers, presentations, talking points, and/or physical travel to the destinations.
- c) Identify opportunities, recommend and develop suggested business models for least-cost solar development strategies in the solar systems of focus in the countries.
- d) Support ISA on ISA country missions to engage with Stakeholders in the countries of focus for regulatory support. This support may include training, capacity building, drafting position papers, presentations, talking points, and/or physical travel to the destinations.
- e) Provide practical recommendations for requisite enabling regulatory frameworks to incentivize investments and engender mini-grid deployments and the adoption of other solar systems as commercially viable sustainable projects in the Potential Countries.
- f) Deliver two comprehensive regulatory framework as identified for establishment in the select countries.

6. Expected Outputs

- a) A detailed analytical report on Solar Energy in Pacific Island states covering the regulatory frameworks of the Potential Countries, detailing the Scope of Work in paragraph D above and their impact on solar-energy solutions deployment in the country. This report will include recommendations on plausible approaches or strategies for regulatory and policy changes or amendments to promote mini-grid and solar energy sustainable least-cost strategies or business models.
- b) Develop a pipeline of recommendations categorized into immediate, short-term, medium-term, and long-term products to accelerate the development of least-cost strategy business models for accelerating solar energy penetration and scale in each country.
- c) Design a comprehensive policy and regulatory framework for sustainable solar energy integration in the Potential Countries. This last phase is to develop at least two requisite energy solar energy regulatory framework for least-cost strategies for sustainable solar energy deployment and scale in each country. The envisaged task will include a practical hands-on approach to drafting or redrafting
