#### 1. BACKGROUND

International Solar Alliance is a global platform of 119 Member Countries working towards increased deployment of solar energy technologies to improve energy access, energy security and facilitate energy transition. ISA supports low-carbon growth trajectories of member countries by accelerating deployment of solar. ISA Secretariat, headquartered in Delhi, India, offers services under three strategic priorities: 1) Policy & Capacity Building; 2) Programmatic Support and 3) Analytics & Advocacy. The Alliance has established partnerships with multilateral development banks, development financial institutions, private and public sector organisations, civil society and other international institutions to achieve its objectives.

#### 2. PURPOSE

As part of its 'leave no one behind' strategy, ISA is working to ensure a 'just and inclusive energy transition' through its gender mainstreaming and empowerment initiatives. 'Solar for She' (SfS) is ISA's gender programme that aims to enhance women's access to energy and employ them in the solar sector. As part of this programme, ISA will be initiating pilot projects in Ethiopia, Guinea (Conarky) or Nigeria to skill train women on specific solar solutions and assist them in employment.

ISA would like to hire agenc(ies) to conduct formative research and help design two pilots in Guinea and Nigeria. Interested agencies can submit proposals for one or both countries.

#### 3. SCOPE of WORK

The contracted agency will support ISA through the following activities:

- a. <u>Site selection</u>: Based on secondary research and in consultation with ISA, the selected agency is expected to narrow down the focus to two specific sites (one per country) where the primary research will be conducted for initiating Solar for She pilots. The site selection should be based on two important criteria a) no duplication with similar initiatives; and b) maximum impact through SfS pilots.
- b. <u>Needs assessment:</u> In these sites, the agency will conduct either primary surveys or focus group discussions with women to assess their energy needs, knowledge/skilling gaps on solar etc. (Sample size: min. 200 across both sites)

c. <u>Market research</u>: In the selected target sites, the agency will also undertake rapid market research of at least five suitable solar solutions (both centralised and decentralised) where women can be trained and employed. As part of this activity, the agency will undertake site visits to markets and conduct key informant interviews (KIIs) with at least three vendors/manufacturers/solar players per solution. The agency is expected to study the entire value chain of each solar solution and identify employment opportunities for women.

(Sample size: 5 solar solutions \* 3 KIIs = 15 across both sites)

- d. <u>A country and situational assessment</u> in terms of government, NGO, UN/other development initiatives that are closely aligned to the pilot should also be provided, so duplication can be avoided, and potential partnerships can be explored. The agency is expected to consult with key policy makers/govt. officials, funders, implementation/development agencies. (*Sample size: min. 12 across both sites*)
- e. <u>Value Chain Analysis:</u> Based on the needs assessment, market research and situational assessment for each solar solution (for example: solar lights, mobile chargers, rooftop solar, solar battery etc.): a complete analysis should be presented in terms of its need in the target area, the solar solution's value chain, where and how women can value add and generate income, skills required, credit linkages, other players (government, NGOs, private) in that sector, cost-benefit analysis, potential benefits in terms of GHG emissions reduction, increased energy access, increased incomes etc.
- f. <u>Partnerships:</u> The agency is also expected identify and assess two local organisations per site, who could be potential partners in implementing the 'Solar for She' pilot. A detailed analysis of the organisations' profile and suitability for the partnership should be presented. Additionally, the agency will also identify microfinance institutions, private sector players and other stakeholders in the target area with whom partnerships need to be built for implementing the pilot.
- g. <u>Pilot Design</u>: Based on the above tasks, in consultation with ISA, the agency will finalise the pilot design including the target sites, target groups, implementation modalities, partnerships etc. and develop a programme document on the pilot2 including a results framework.
- h. <u>Communication</u>: The agency will also create collaterals on 'Solar for She' one brochure, one power point presentations, 1-2min video on each Solar for She pilot. The agency is also expected to assist ISA remotely in launching the pilots. The launch will include a panel discussion or similar event to promote ISA's Solar for She pilots, which the agency is expected to coordinate in terms of identifying

and inviting panelists, developing the panel discussion format/note with key talking points and a short 3-5page summary note post the event.
